The State Social Security Administrator's Office had contacted our District informing us that Central County Fire and Rescue was not covered for legal Social Security withholdings since the consolidation. The Social Security Office took a vote of Central County Fire & Rescue's employees to extend permanent, irrevocable Social Security coverage. The employees of Central County Fire and Rescue voted in favor of continuing Social Security coverage. Resolution #138 relates to the agreement between Central County Fire and Rescue, the State of Missouri and the United States Social Security Administration. Patricia Hamm made a motion to adopt Resolution #138. There was a second by Robert Carpenter. Chairman Tilley read the title of Resolution #138.
